

AKROPOLIS Gift Voucher Usage Rules:

1. AKROPOLIS Gift Voucher (hereinafter referred to as the "Gift Voucher") may be bought:

- The shopping and entertainment centre AKROPOLIS, **Vilnius** - in the ticket sales network Tiketa, or in the shops "Megaturas", „3D stikle“, „SWATCH“, „Baitukas“.
 - The shopping and entertainment centre AKROPOLIS, **Kaunas** - in the ticket sales network „Tiketa“, or in the shop „Tele 2“.
 - The shopping and entertainment centre AKROPOLIS, **Klaipėda** - in the ticket sales network „Tiketa“, or in the shops "Klaipėda", "Megaturas", "Klaipėdos perlas", "Eurolines" .
 - The shopping and entertainment centre AKROPOLIS, **Šiauliai** - in the ticket sales network „Tiketa“.

2. Denominations of Gift Vouchers: LTL 25, LTL 50 LTL, 100 LTL, 200LTL, 500LTL.

3. The Gift Voucher is valid in shops/ service/ entertainment places located in the shopping and entertainment centres AKROPOLIS, Ozo Str. 25, Vilnius, Taikos Ave. 61, Klaipėda and Karaliaus Mindaugo Str. 49, Kaunas, in which information is presented about the possibility to pay by the Gift Voucher in that place.

4. The Gift Voucher is valid for 3 (three) months from the day it was bought.

5. The dates from which to which the Gift Voucher is valid are specified on the Gift Voucher.

6. The Gift Voucher may not be cashed in.

7. The Gift Voucher may not be used while paying for tobacco products.

8. No VAT invoice shall be written for bought Gift Vouchers.

9. If the price of an article(s) for which the payment is made by the Gift Voucher is higher than the nominal value of the Gift Voucher specified on the Gift Voucher, the outstanding amount shall be paid in cash, by a credit or debit card.

Gift Voucher you can't use for the payment:

In the shopping and entertainment centre AKROPOLIS, **Vilnius**: "Slenkančios sistemos", "Silka", "Tabakas", "Bilietai LT", "Tiketa", "Vynoteka", Shoes repair service, Betting companies, Banks, Credit companies.

In the shopping and entertainment centre AKROPOLIS, **Klaipėda**: "Tiketa", "Vynoteka", "Bilietai LT", Shoes repair service, Betting companies, Credit companies, Banks.

In the shopping and entertainment centre AKROPOLIS, **Kaunas**: "Lietuvos draudimas", "R- kioskas", "Raktų dirbtuvė", "Bilietai LT", Shoes repair service, Betting companys, Credit companys, Banks.

In the shopping and entertainment centre AKROPOLIS, **Šiauliai**: „R-Kiosk“, „Skonis ir kvapas“ (Tabakas), „X-Games“, „Tiketa“, Betting companies, Banks, Credit companies.

10. If the price of an article(s) for which the payment is made by the Gift Voucher is lower than the nominal value of the Gift Voucher specified on the Gift Voucher, the margin shall not be refunded.

11. When the Gift Voucher is presented for settlement, it shall be taken for good. It is poible to use the Gift Voucher for payment only once, later the voucher is annulled.

12. The Gift Voucher is protected by a unique barcode and other security means.

13. If the Gift Voucher has been damaged, i.e., more than half of it has been stained, is missing or harmed otherwise, or if there is no number or validity term on the Gift Voucher, it shall not be possible to pay for goods and/or services by such a Gift Voucher, and such a Gift Voucher shall not be replaced or money refunded for it.
